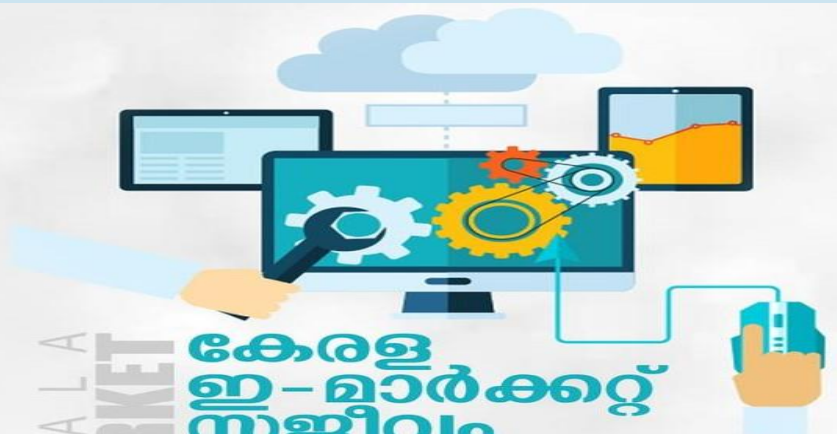

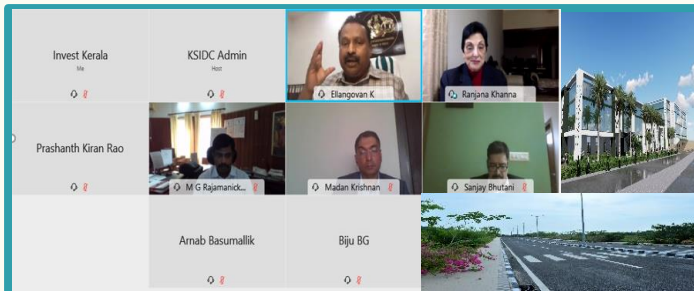
State to be made a hub for latex-based products

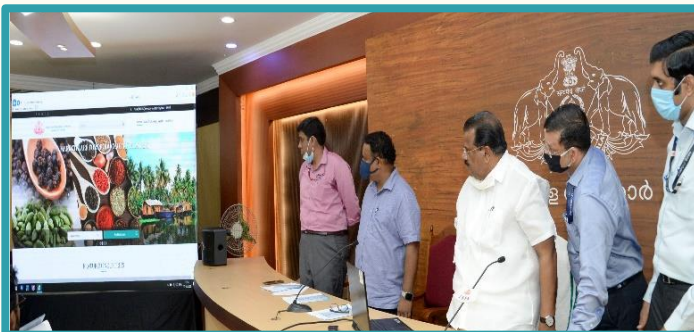
CFC worth Rs.11.65 Crores in Wood Furniture Cluster, inaugurated by the CM via Video Conference

ENTREPRENEUR SUPPORT SCHEME (ESS)

- Investment in Land, Building, Plant & machinery, Electrification, Essential Office Equipment's, Pollution Control Devices and other fixed assets are eligible
- For General Category Assistance is 15% limited to Rs 20 lakhs
- For Young (18 to 45 years), Women and SC/ST entrepreneurs, the assistance is 20% limited to Rs 30 lakhs
- Enterprises in priority sector is eligible for an additional assistance of 10% limited to Rs 10 lakhs
- MSMEs started in the districts of Idukki, Wayanad, Kasargode and Pathanamthitta are eligible for an additional support of 10% limited to Rs 10 lakhs
- Industries setup after acquiring new technology from approved research institutions are eligible for an additional support of 10% limited to Rs 10 lakhs
- The total eligible assistance for an enterprise is limited to Rs 30 lakhs

PM FME SCHEME

The Ministry of Food Processing Industries, Government of India in partnership with the State / UT Governments, has launched an all India Centrally Sponsored PM Formalization of Micro Food Processing Enterprises Scheme (PM FME Scheme) for providing financial, technical and business support for upgradation of existing Micro Food Processing Enterprises as part of Atmanirbhar Bharat Abhiyan.

The Scheme adopts One District One Product (ODOP) approach to reap benefit of scale in terms of procurement of inputs, availing common services and marketing of products. Government of Kerala has nominated Industries Department as the Nodal Department, Kerala Bureau of Industrial Promotion (KBIP) as the State Nodal Agency with Managing Director, KSIDC as the State Nodal Officer and Kerala Agricultural University, Thrissur as the State Level Technical Institution (SLTI) for the implementation of the Scheme.

ACHIEVEMENTS GALLORE



Kerala ranked first among large States in overall ranking of the **Public Affairs Index 2020** - Governance of Indian States.

The Public Affairs Centre (PAC) releases the Public Affairs Index (PAI) annually. The index measures the quality of the governance of India States at the subnational level. It uses a Composite Index (CI) to rank Indian states and Union Territories.

Kerala has bagged **1st Rank in Public Affairs Index-Growth Pillar (large States) and Sustainability Pillar (large States)**. Kerala is also the **best governed State in India** as per the Public Affairs Index.

A special package for MSMEs: VYAVASAYA BHADRATHA

The COVID-19 pandemic has adversely affected the functioning of MSMEs. Considering this, the State Government announced a Rs 3434 crore special package to help small and medium scale businesses tide over Covid-triggered financial crisis.

The special revival package of **Relief Schemes and Financial Assistance for MSMEs** was launched under the title "VYAVASAYA BHADRATHA".

The package includes:

1. New Land Premium Payment Policy
2. Freezing of Land Premium for One Year
3. Waving of Standard Design Factories (SDF) rental for 3 months
4. Waiving of common facilities charges for 3 months
5. Top Up loans in KSIDC
6. Waiver of Penal Interest for existing customers of KSIDC
7. Moratorium for payment of Principal & Interest – KSIDC
8. One Time settlement policy for KSIDC & KINFRA
9. Special loans for asset creation for MSMEs by KSIDC
10. Entrepreneur Support Schemes (ESS) to be liberalized
11. Margin Money assistance for Additional Working Capital & Interest Subvention on Additional Working Capital loan for MSMEs
12. Interest Subvention for Additional Term Loans for MSMEs
13. ESI Contribution of Employers for 3 months
14. PF contribution of Employers for 3 months
15. Modification of NPA Norms
16. Extension of moratorium for Principal & Interest to 6 months
17. Payment of moratorium period for MSMEs

DIC SPEAK: FROM THE DIRECTOR'S DESK

What is the major function of the Directorate of Industries and Commerce ?

Directorate of Industries and Commerce is dealing with the implementation of various industrial activities and is responsible for promoting / sponsoring, Registering, Financing and advising MSMEs (Micro Small or Medium Enterprise) in the state. The role of directorate is to act as a facilitator for industrial promotion and sustainability of MSMEs (Micro Small or Medium Enterprise) and traditional industrial sector in the state.

What services do the Directorate of Industries and Commerce offer to the entrepreneurs?

Directorate of Industries and Commerce is the controlling office of the 14 District Industries Centres, Common Facility Service Centres at Changanacherry and Manjeri and Documentation Centre. Through these facilities the Directorate of Industries and Commerce provides to MSME entrepreneurs Financial Incentives (Entrepreneur Support Scheme), Facilitation Services (Single Window Clearance Board, LOG License etc.), Capacity Building (Entrepreneurship Development Programme, Entrepreneurship Awareness Programme, Technology Clinic, Investors Meet etc.), Infrastructure Facilities (Industrial Development Area and Plots across the state), marketing and commercial assistance (Organise Exhibitions, Assistance to participate in National and International Events, MSME portal) etc.

What are the services offered by the Directorate of Industries and Commerce towards rebuilding the industrial sector in the wake of the COVID-19 Pandemic ?

The Directorate of Industries and Commerce is responsible for providing assistance to rebuild the MSME sector affected by the COVID-19 Pandemic. In this context, the Directorate is implementing an Interest Subvention Scheme for the MSMEs affected by the pandemic, as part of the Vyavasayabhadra scheme by the State Government. The Directorate is also coordinating and facilitating components of the Atmanirbhar Bharat Scheme - Emergency Credit Line Guarantee Scheme, Credit Guarantee Scheme for Subordinate Debt, CGSSD for Stressed/NPA MSMEs etc., announced by the Government of India
